## **OUTBREAK OF LEGIONNAIRES' DISEASE - SOUTH-WEST EDINBURGH**

- As you will be aware, since Thursday, 31 May 2012 NHS Lothian has been notified of 24 confirmed cases of Legionella and 37 suspected cases (to 12pm on 7 June 2012).
- The majority of these have been admitted to hospital with severe respiratory illness and one confirmed case has died. The earlist onset date of the confirmed cases to date is 16 May 2012. All the confirmed cases have tested positive for Legionella pneumophila SG1 urinary antigen.
- 3. Local cooling towers on sites in or adjacent to the affected area have been identified as the most likely source of the organism. Initial assessment and disinfection has been carried out and further follow up visits are being undertaken by the Health and Safety Executive and the City of Edinburgh Council's Environmental Health Department.
- Clinicians are asked to consider Legionnaires' disease as a possible diagnosis in patients who present with flu-like symptoms and/or lower respiratory tract symptoms, or severe respiratory illness, and who have worked or stayed in South-West Edinburgh from mid May until the first week of June inclusive.
- 5. Clinicians are also asked to consider arranging testing of urine samples for Legionella antigen, and sputum for Legionella, on all suspected cases.

- 6. Clinicians are also reminded that while Legionnaires' disease is <u>not</u> a notifiable disease under the Public Health etc (Scotland) Act (2008), Legionella <u>is</u> a reportable organism. Accordingly, there is a duty on directors of diagnostic laboratories to report all laboratory detections of Legionella to the local public health department.
- 7. Where any cases are suspected or confirmed public health departments should notify Health Protection Scotland as a matter of urgency, to ensure any further cases can be interviewed as quickly as possible.
