HOURS OF WORK OF JUNIOR DOCTORS AND DENTISTS

Summary

1. This letter sets out intermediate targets for the implementation of "The New Deal" on the hours of work of junior doctors and dentists.

Action

- 2. The Ministerial Group on Junior Doctors' Hours met on 29 April to consider the latest progress reports. Tackling this long standing issue has not been easy, but it is clear that headway is being made. I would therefore like to express my thanks to all those involved.
- 3. It is essential to maintain the momentum and the Ministerial Group therefore decided that it would be helpful to set a target date of 1 April 1993 to bring hours down to a maximum average of 83 per week. A Ministerial announcement is to be made about this today. I recognise that this will be a challenging task but it is one to which I am sure Health Boards and Trusts can rise. Health Boards and Trusts will need to ensure that new contracts issued in February and March 1993 comply with the hours controls. I have asked The Scottish Implementation Group to discuss the practical steps that will need to be taken to deal with the particular problems of small specialities, rural areas and dispersed patterns of service provision.
- 4. This issue has also been discussed recently by the Manpower Joint Working Group which recognised that it would be useful to set down some further milestones on the road to our objectives for December 1994. I therefore propose that employing bodies should aim for 50% of their juniors doctors on on-call rotas in hard pressed posts to be contracted for no more than 72 hours per week by 1 April 1994 leaving the remaining 50% to be reduced to a commitment of 72 hours (or to 64 and 56 hours respectively for those on partial or full shifts) by 31 December 1994.
- 5. I would remind you that the Government attaches great importance to the successful conclusion of this initiative and the Scottish
