HEALTH SERVICE ESTATES MANAGEMENT: PROPERTY TRANSACTIONS PROCEDURES

#### Summary

- 1. This letter introduces a revision to the trawl circulation list at Appendix 6 of Annex H of NHS MEL(1992)8. The effect of the revised circulation list is to require trawl notices to be sent direct to CSA, rather than to the Management Executive in the first instance, as at present. In this letter the term 'Health Board' or 'Board' should also be read as meaning the Common Services Agency.
- 2. A copy of the revised circulation list is attached and should be substituted for the original list at Appendix 6 to Annex H of MEL(1992)8, which can now be destroyed.

#### Action

- 3. Boards are asked to introduce the new arrangements with immediate effect.
- 4. General Managers should bring this letter to the attention of all staff responsible for property transactions.
- 5. This letter should be copied to Unit General Managers for action as required.
