FIRE TRAINING FOR NHS STAFF 1994

Summary

1. This letter announces the dates and other details of fire training courses for NHS staff to be held this year at the Scottish Fire Service Training School at Gullane. The training offered is:

Five day courses on basic hospital fire safety. Three day workshops for specialist fire safety advisers.

One day seminar for senior managers.

- 2. Two changes in the arrangements from earlier years should again be noted. The first is that NHS Trusts and Units, rather than Health Boards, are now responsible for nominations and that Management Development Group, rather than Estates Division, is responsible for collating bids, allocating places and providing the administrative link with the Fire School.
- 3. The Annex to this letter provides the relevant information and procedures.

Action

4. NHS Trust Chief Executives and Unit General Managers should put in hand procedures for submitting bids to MDG for the above events particularly for the first 5 day course by 21 March.

ANNEX

FIRE TRAINING FOR NHS STAFF 1994

- 1. The Management Executive places the highest value on fire training for all NHS staff. If the good record on fire safety in the Health Estate in Scotland is to be maintained, training appropriate to each level of responsibility in the service, professionally organised by the Scottish Fire Service Training School at Gullane, will remain essential for the safety and well being of patients, visitors and staff in all NHS premises.
- 2. The training programme is reviewed each year in response to new legislation and guidance and to feedback on the content and style of courses.
- 3. This year, the Fire Precautions (Places of Work) Regulations are finally to be implemented and will have far reaching effects on fire safety practice and procedures, requiring risk assessment techniques to underwrite decisions and determine priorities in this and other matters effecting health and safety. Mastering these techniques will be given particular emphasis in the Three Day Workshops for Specialist Fire Safety Advisers. Also to be implemented this year is a new version of Firecode in Scotland Policy and Principles, which requires, among others, the nomination of an Executive Director within each Trust or Unit, to be responsible directly to the Chief Executive or General Manager for fire safety. The One Day Seminar for Senior Managers should be "de rigueur" for these new nominees. Meanwhile, the well established Five Day Courses on Basic Hospital Fire Safety will continue to provide the practical training for health care staff, particularly the nominated officers (fire) and their deputies, who are expected to be the first to respond to an outbreak of fire and take command until the arrival of the brigade.
- 4. As in previous years, the review continues to show a mismatch, in the case of some Trusts/Units, between the numbers attending courses and the size and complexity of their estates. Chief Executives should themselves review and consider most carefully, the numbers of staff trained in fire safety at all levels and whether these are appropriate to developing needs and responsibilities. Attendances were poor last year and the One Day Seminar was cancelled due to lack of support. Difficulties may have been experienced in transferring responsibilities from Boards to Trusts and Units and setting up training places but procedures and personnel must now be in place, with time and finance set aside for the training of key staff in fire safety. It is doubtful if anyone in the chain of command could be excused if negligence were proved in any enquiry, following a fire in NHS premises.
- 5. Arrangements have been made, therefore, by the Fire School at Gullane to hold the following training sessions.

Five Day Course on Basic Fire Safety

Course 1 1200 hrs Monday 18 April 1430 hrs Friday 22 April Course 2 1200 hrs Monday 31 October 1430 hrs Friday 4 November

Three Day Workshops for Specialist Fire Safety Advisers

Workshop 1 1230 hrs Tuesday 28 June 1545 hrs Thursday 30 June Workshop 2 1230 hrs Tuesday 9 August 1545 hrs Thursday 11 August

(Workshop 1 on new buildings and workshop 2 on existing buildings are complementary. An officer may attend either or both.)

One Day Seminar for Senior Managers

- 6. The courses and workshops are residential and are planned to optimise travelling and catering arrangements, starting with lunch and finishing after lunch or tea. Coffee, lunch and tea are also provided for the seminar. Costs for the courses will be around £400 (inc VAT), for the workshops £200 and for the seminar £50. Numbers for the courses and workshops are restricted to 20 and for the seminar about 50.
- 7. NHS Trust Chief Executives, actual and designate and Unit General Managers are invited to prepare a list of nominations for each of the above sessions, submitting it in writing to Management Development Group at the address given, no later than 4 weeks before the start of the respective event. The name, designation and location of each officer should be indicated.
- 8. MDG will collate the submissions and if over-subscribed, allocate places. It is important therefore that each Trust/Unit identify a single contact point co-ordinator, a training officer, for example, who may be telephoned or faxed to negotiate final numbers. Consideration should also be given to nominating reserves, should the allocated officer be unable to take up his/her place. A charge may otherwise be made for non-attendance.
- 9. MDG will inform the officers finally allocated, providing travel and other relevant information, copying the agreed lists to the co-ordinator and Fire School. Following completion of the courses and workshops, certificates of attendance will be sent to the co-ordinator for distribution and for all events, invoices cleared through finance departments.
- 10. A syllabus for each course and workshop is enclosed. That for the seminar will follow. Any further information may be obtained from MDG at the address and telephone number given.
