HEALTH BUILDINGS IN THE COMMUNITY

Summary

- 1. I am pleased to draw your attention to the enclosed publication "Health Buildings in the Community".
- 2. This document has been produced for use within the NHS in England but is equally relevant here. It will be of benefit to all those involved in developing community facilities whether they be GP practices, local health resource centres or community hospitals. The theme of the Report is that better buildings can help make people better and the design, detailing and management of health buildings can have a significant influence on the well-being of patients.
- 3. The publication brings together experience gained through local initiatives and seeks to set the standard for the design of local health buildings. It is a high but realistic standard, based on what has been achieved within the NHS. It does not prescribe a formula for design, but presents a range of solutions to further encourage innovation and local interpretation of the principles of comfort, safety and dignity.
- 4. The Patients Charter and internal market have put more emphasis on quality issues; a poor environment can work against the high quality and dedicated care delivered by individuals and teams. Linked to a policy to provide high quality health services as near peoples homes as possible, the document highlights factors which most influence a patient's perception, and shows examples of best practice which should set the standard for the design of buildings providing healthcare in the community.

<u>Action</u>

5. All those with an interest in the provision of healthcare outwith the general hospital environment are invited to draw on the publication as a useful aid in efforts to provide quality healthcare in appropriate surroundings.
