SCOTTISH HEALTH PURCHASING INFORMATION CENTRE

REPORT ON DYSPEPSIA, PEPTIC ULCER AND HELICOBACTER PYLORI

Summary

- 1. A report by the Scottish Health Purchasing Information Centre on Dyspepsia, Peptic Ulcer and Helicobacter Pylori is attached.
- 2. The Report examines treatments for dyspepsia and peptic ulcer, and in particular the eradication of the bacterium Helicobacter Pylori, which is present in nearly all cases of gastritis and gastric and duodenal ulcer.
- 3. The Report concludes that:
- a. eradication therapy should replace acid reducing drugs in the treatment of most patients with peptic ulcer;
- b. breath testing for Helicobacter Pylori should be made available to GPs; and
- c. Helicobacter testing will reduce the number of endoscopies required.
- 4. This is the Scottish Health Purchasing Information Centre's first Report. It will publish a series of further Reports, including a number of Common Core Work Programme topics, during the year.
- 5. Information on the Common Core Work Programme and the Scottish Health Purchasing Centre is given in the Annex. Clinical guidelines on Helicobacter Pylori will be issued in the next few weeks by Scottish Intercollegiate Guidelines Network.

COMMON CORE WORK PROGRAMME

The Common Core Work Programme is designed to steer the efforts of professional and other groups working at a national level in the pursuit of clinical and cost effectiveness, to reduce duplication of effort, to limit the number of national imperatives to a manageable number and to co-ordinate local and national imperatives.

Its purpose is to help improve health and the quality, effectiveness and cost-effectiveness of clinical care by providing the Service with information and advice, such as needs assessment or clinical guidelines on a small number of important clinical topics.

Much of the work of the Programme supports the 3 Service priority areas of cancer, mental health and coronary heart disease/stroke, but it is not limited to these areas. It also includes topics which are important because there is clear immediate potential to improve health and/or clinical care. The topics for 1996-97 are:
