### Action


- 2. The new commitments affecting the Scottish Health Service are set out in the Annex to this letter.

# **Waiting Times**

- From April 1996, a 12 month long-stop target for in-patient and day case treatment was introduced and from April 1997 this will be converted to a guarantee.
- At least one new local in-patient waiting time guarantee is to be added each year to the existing 6 local guarantees.

## **Improving Patient Information**

- From April 1996 patients have a right to seek a review of the clinical decision on their continuing health care.
- From September 1996 patients have a right to receive written information about services before admission to hospital.
- From September 1996 patients have a right to be told before going into hospital whether care is to be provided in a single or mixed sex ward.
- A commitment to increase the number of General Practices producing their own charters, practice plans or patient information leaflets with the aim to increase coverage to 50% of practices by the end of 1997.

### Treating People as Individuals .

- By June 1997 all patients will have a named nurse.
- A pilot scheme will be set up to provide patients with written information in simple language on their discharge from hospital.

## **Quality of Care**

- Information on clinical outcome indicators contained in the Reports published in 1994, 1995 and 1996 will be progressively expanded.
- The Scottish Intercollegiate Guidelines Network will produce more evidence-based guidelines to promote clinical effectiveness.
- Systematic audit of clinical care will continue to be developed.
