SCOTTISH CANCER CO-ORDINATING AND ADVISORY COMMITTEE: COMMISSIONING CANCER SERVICES IN SCOTLAND REPORT: PRIMARY AND PALLIATIVE CARE SERVICES, JULY 1996

Summary

- The "Commissioning Cancer Services in Scotland" revised report (April 1996) was issued in May of this year under cover of NHS MEL(1996)54. While its main purpose was to publish the report and to set out a series of objectives and milestones for Health Boards and NHS Trusts, this letter also indicated that the SCCAC Sub-Committee had been asked to prepare a second report on primary and palliative care services by the end of the summer 1996.
- 2. This report has now been completed and is attached.
- 3. This letter seeks comments on the "Primary and Palliative Care Services" Report from Health Boards, NHS Trusts, those organisations listed in the Annex to this letter and any other bodies with an interest in the care of patients with cancer.

Action

- 4. Bearing in mind the general principles outlined in the first report "Commissioning Cancer Services in Scotland" (April 1996), the objectives and planning milestones for the reconfiguration of cancer services set out in NHS MEL(1996)54 and the further guidance set out in NHS MEL(1996)83, comments are sought on:
- (a) the implications for the service of the principles set out in the report, and
- (b) particular issues arising from the action points, e.g. (but not exclusively) in relation to referral patterns, training and inter-disciplinary/inter-agency communications and working patterns.


