NHSSCOTLAND PROPERTY TRANSACTIONS HANDBOOK 2011

Summary

- This letter advises colleagues of the publication of a revised edition of the NHSScotland Property Transactions Handbook. The Handbook is now only available in a web-based edition on the SGHD Capital and Facilities website - direct link: http://www.pcpd.scot.nhs.uk/PropTrans/PTHome.htm
- This CEL and the revised edition of the Handbook supersedes NHS Circular HDL(2001)15: "NHSScotland Property Transactions" issued on 26th February 2001.

Action

- 3. Addressees should ensure that a copy of this CEL is cascaded to all appropriate staff within their area of responsibility.
- 4. The revised edition's Mandatory Requirements and supporting guidance are, in the main, unchanged and take immediate effect.

Background

- 5. The NHSScotland Property Transactions Handbook is intended to ensure that NHS property is bought, sold and leased at a price and on other conditions which are the best obtainable for the public interest at that time.
- 6. The Handbook is intended to be a ready source of reference on SGHD policy and related requirements, guidance thereon and on the more operational aspects of all heritable property transactions.
- 7. NHSScotland Holding Bodies should ensure that their staff and external advisers are fully familiar with the contents of the Handbook, particularly when they are seeking advice on specific issues.
