# PHARMACEUTICAL SERVICES SUPPORTING QUALITY IMPROVEMENT: 2018 ACTIVITIES

## Summary

1. This Circular advises community pharmacy contractors and NHS Boards of initiatives to continue to strengthen and raise the profile of Quality Improvement activity within community pharmacy.

## **Background**

- 2. Circular PCA(P)(2016)15, issued in September 2016, introduced Quality Improvement as a key focus of the Community Pharmacy Contract. It is intended that continuous Quality Improvement should be a feature of the community pharmacy funding settlement going forward.
- 3. Circular PCA(P)(2017)13, issued in November 2017, advised that a non-recurring annualised pool of £2.0m, had been identified for Quality Improvement activities, building on the patient safety work previously undertaken.

#### **Details**

- 4. A single payment of £1,600 was made in November 2017 paid January 2018 to community pharmacy contractors on the list at 1 April 2017.
- 5. This payment is for **completing two quality improvement activities**:- undertaking the Safety Climate Survey and developing an action plan; and participation in Non-Steroidal Anti-Inflammatory Drugs (NSAIDs) Interventions.

#### **QUALITY IMPROVEMENT 2018 ACTIVITIES**

## Continuous Improvement: Safety Climate Survey - Activity A

- 6. Circular PCA(P)(2016)15 required all pharmacy teams to undertake the Safety Climate Survey, which was designed and tested via the Scottish Patient Safety Programme.
- 7. Following on from this, contractors are requested to again complete the Safety Climate Survey and this time to develop an action plan based on the results by 30 September 2018 (Template at Annex A and also available at web link <a href="http://ihub.scot/media/1784/20170412-pharmacy-action-plan-1-0.pdf">http://ihub.scot/media/1784/20170412-pharmacy-action-plan-1-0.pdf</a>). The results of the survey will form a baseline for each contractor, with the intention being that the Safety Climate Survey will be repeated on a biennial basis such that improvements can be tracked internally by each pharmacy team.
- 8. Feedback from last year's Pharmacy Quality roadshows and Safety Climate Survey activity indicated that there was a desire from pharmacy teams for support with using root cause analysis (RCA) tools to support continuous improvement in the community pharmacy setting. An introductory RCA pack has been developed for this purpose, and can be found on the Community Pharmacy Scotland website (<a href="www.cps.scot/RCA">www.cps.scot/RCA</a>). Pharmacy teams should familiarise themselves with these tools to facilitate improvement in response to near misses, dispensing incidents and feedback including complaints.

## Non-Steroidal Anti Inflammatory Drugs (NSAIDs) Interventions – Activity B

- 9. Reducing the risks associated with the use of High Risk Medicines and specifically non-steroidal anti-inflammatory drugs (NSAIDs) is an area of focus within the Scottish Patient Safety Programme (SPSP). NSAIDs are more likely to be associated with emergency hospital admissions due to adverse drug reactions than any other drug class. NSAIDs are frequently dispensed and sold over the counter in community pharmacies, and evidence has shown that consistent delivery of a structured intervention (care bundle) can improve patient awareness of how to minimise the risks associated with NSAID treatment e.g. GI bleeds and kidney injury.
- 10. Healthcare Improvement Scotland (HIS) will distribute a Quality Improvement Toolkit to each community pharmacy in May 2018. This will contain a range of Quality Improvement tools and guidance to support quality improvement in community pharmacy practice in general. A NSAID communication bundle makes up part of this toolkit and forms the basis of Activity B. HIS will be writing to all community pharmacies shortly with more information about the Toolkit.
- 11. All the materials and instructions necessary to undertake this activity can be found in the toolkit. All contractors should use these materials to train staff involved in the supply of medicines to patients to:
  - Deliver the bundle of three safety messages to all patients prescribed or purchasing NSAIDs during the period 1 June – 30 September 2018.

- Collect small samples of data about how consistently the messages are delivered throughout this period.
- Track improvement in the delivery of the three safety messages over time.

This activity is designed to encourage internal quality improvement. Contractors will not be required to report the data collected nationally but are asked to use this methodology to drive engagement in this and any future patient safety improvement exercise.

- 12. The focus is on communication as a pharmacy team: talking to patients and making sure they are taking their medicines safely. There are three key safety messages that should be covered in the consultation with patients and this will feature in the QI Toolkit. Pharmacy teams should use their weekly data collection to reflect on how effectively they are delivering the NSAID key messages and what steps they can take to improve this practice.
- 13. This initiative aims to have an emphasis on continuous improvement and help embed practices within the pharmacy team that can be reviewed and reflected upon. All contractors are to complete the feedback form at Annex B and retain locally. Boards may put in place local arrangements to collate the forms.
- 14. NES and HIS, with support from existing local Quality Improvement (QI) teams, will support the implementation of the NSAID communication care bundle in community pharmacy practice through a webinar on 8<sup>th</sup> March followed by local face to face events. These events are open to the pharmacy teams and will help them understand and embed Quality Improvement methodology, and apply the concept of care bundles into their own practice.

## Action

- 15. As detailed above, the payment for this activity was made in November 2017 paid January 2018. All community pharmacy contractors that were eligible for this payment must either complete and sign the declaration attached at Annex C, and return it to NSS Practitioner Services Division by 30 April 2018 to confirm that they will undertake these two activities, <u>or</u> complete the electronic version of the declaration form hosted by Community Pharmacy Scotland at <u>www.cps.scot/QI2018</u> by 30 April 2018 to confirm that they will undertake these two activities.
- 16. The signed declaration will used for payment verification purposes. Contractors should keep a local record of activity undertaken for future inspection by Payment Verification Services on request.
- 17. Community Pharmacy Scotland has been consulted on the contents of this Circular.
- 18. NHS Boards should share a copy of this Circular and bring it to the attention of community pharmacy contractors, local pharmacy committees and Health and Social Care Partnerships.
