We the undersigned, declare that the recommendations of the Office of Fair Trading to abolish the Control of Entry regulations contained in NHS (Pharmaceutical Services) (Scotland) Regulations 1985, regulation 5 (10), fails to recognise the vital NHS services provided by the current network of pharmacies in Scotland, and if implemented would have a negative effect on community pharmacy and patient care in Scotland.

We value the services of our local NHS pharmacy and oppose any action which would jeopardise its stability.

The petitioners therefore request that the Scottish Parliament call upon the Scottish Executive to retain the existing regulations and disregard the recommendations of the OFT.
