Remuneration Increase 2022-23: Chairs And Non-Executive Members

1. I am writing to advise you of the revised annual rates of remuneration payable to Chairs and other Non-Executive members of Health Boards, Special Health Boards and Healthcare Improvement Scotland. Other Health Bodies will be advised separately by their Scottish Government Sponsor Teams.

Background

- 2. The revised rates reflect a £1.92 increase (the maximum increase that can be applied to Daily Fees over £154), in accordance with the Public Sector Pay Policy for 2022-23 and are set out in the table overleaf.
- 3. Please note that this replaces the information contained in DL(2021)45.

Changes to taxable expenses for Chairs and Board Members

4. The UK Government changed the HMRC rules on taxable expenses for Chairs and Board Members in April 2019 and this information can be found in <u>DL(2019)20</u>. It reminds Public Bodies that they can cover the cost of travel and subsistence expenses of Chairs and Members by "grossing up" payments for expenses.
